20% Welcome Bonus Terms and Conditions

1. Introduction

By participating in the Deposit Bonus Campaign (the “Campaign”), clients agree to these Terms and Conditions.

2. Eligibility

The Campaign is available to new and existing clients who meet BBS Markets Ltd (hereinafter ‘the Company’) eligibility criteria. The Campaign is available to a selected number of countries and clients. The bonus amount is at 20% of the Clients deposit, with applicable terms and conditions.

2A. Compliance with Laws and Regulations

Participation in the Campaign is subject to compliance with local laws and regulations. Clients are responsible for ensuring that they are legally eligible to participate in the Campaign under the financial regulations of their jurisdiction.

The Company reserves the right to reject participation from any client where regulatory restrictions apply.

All clients participating in the Campaign must comply with the Company’s Know Your Customer (KYC) and Anti-Money Laundering (AML) policies. The Company reserves the right to request additional identity verification, account information, or proof of funds at any time.

Failure to provide such information may result in account suspension or forfeiture of the Campaign.

3. Excluded Countries

This Campaign is not available to clients residing in countries such as the United States, Iraq, and any other jurisdictions where participation would contravene local regulations or as determined by the Company.

Clients in these countries are ineligible to participate in the Campaign. The Company reserves the right to update this list at its absolute discretion, in accordance with regulatory changes.

4. How to Participate

1. Register and verify your account in the Company's Client Portal.
2. Select "Welcome Bonus Account" under the Open Live Account tab on the Menu.
3. Review and accept the Terms and Conditions.
4. Deposit a minimum of USD 10 from your wallet to the new Welcome Bonus account.

The bonus credit is instant and will appear once the funds are transferred.

5. Campaign Details

- The Campaign is available for MT5 Welcome Bonus accounts only.
- You may use Expert Advisors and CopyTrading for trading.
- The Welcome Bonus account has a Margin Call of 100% and a Stop Out level of 50%.

6. Campaign Terms

- The credit can be lost and used to trade.
- Maximum credit per client is \$500.
- New clients receive the credit on their first deposit. Subsequent deposits will not receive a credit.
- The credit can never be withdrawn

7. Withdrawal Rules

- If you perform a withdrawal the credited amount will be removed.

8. General Rules

- Clients can participate in only one type of bonus at a time.
- Internal transfers during the Campaign period are treated as withdrawals concerning the bonus.
- The Company may review negative balances and remove bonuses accordingly.
- The Company reserves the right to amend or end the Campaign at any time without prior notice.

9. Conduct and Fair Play

The Company will not tolerate abusive behavior, which may include but is not limited to indications or suspicions of fraud, manipulation, internal or external hedging, cash-back, bonus or swap arbitrage, or any other forms of deceitful or fraudulent activity.

If such behavior is detected or suspected in a client's account or multiple accounts related to the Campaign, the Company reserves the right to nullify all transactions and/or rebates, bonus amounts, profits, or losses associated therein.

10. Risk Disclaimer

Trading financial instruments, including those with bonuses, carries a high level of risk and may result in the loss of both bonus and deposited funds. Clients should only participate if they fully understand these risks.

The Company does not guarantee any profits or protection from losses arising from trading activity, including losses incurred while using bonus funds.

11. Modification, Suspension and Termination of this Campaign

The Company reserves the right to modify, suspend, or terminate the Campaign at any time without prior notice.

Bonuses are promotional funds granted at the Company's discretion and do not constitute a client's own funds.

The Company reserves the right to remove or adjust bonuses where necessary for compliance, fairness, or operational integrity.

12. Dispute Resolution

The Company In the event of any disputes regarding bonus eligibility, calculation, or withdrawal, the Company's decision shall be final and binding. Clients may submit complaints via the official client support channel. Any disputes must be raised within seven (7) days of the bonus being awarded or removed, failing which it shall be deemed that the calculation is accepted, and no further queries or appeals will be entertained.
